Dear Mr. Roberts:

The City of Anaheim ("City") received your Public Records Act request dated September 20, 2022. Therein, you seek a copy of the following records:

"1. All emails, cellphone texts, letters, correspondence, faxes, photographs, videos, memos, tickets, citations, and/or any other documents (hereinafter referred to as "public records") currently in the possession of the Anaheim Police Department, Code Enforcement, Public Utilities, and Public Works which deal with, address, and/or pertain to any complaints and reports of political signs improperly placed along the sides of roads and streets, right-of-ways, easements, medians, utility poles, fences, and other public property by the Harry Lal campaign, a candidate running for city council in District 6, and their removal by city employees--including the cost of doing such.

The timeline for the aforementioned public records shall be between Friday, August 12, 2022 and [September 20, 2022]."

Subject to, and without waiving, the foregoing exemptions, the City's Planning & Building Department has identified records that fall within the scope of your request.
